| IFRA Category 5A | Body creams, oils, lotions of all types; Foot care products (creams and powders); Insect repellent (intended to be applied to the skin); All powders and talc (excluding baby powders and talc) |
| IFRA Category 5B | Facial toner; Facial moisturizers and creams (including care products for beard and mustache) |
| IFRA Category 5C | Hand cream; Nail care products including cuticle creams, nail lacquer remover, etc.; Hand sanitizers |
| IFRA Category 5D | Baby cream/lotion, baby oil, baby powders and talc |
